
Z1 SECUREMAIL
LICENSE USAGE FOR ZERTIFICON SOLUTIONS SOFTWARE PRODUCTS

Licenses in general: In principle, concerning Z1 SecureMail products, only internal users are obliged to license. Depending on the manner of use of the Z1 SecureMail products, the internal users are divided into "**Active Clients**" and "**Passive Clients**".

Z1 SecureMail: Concerning Z1 SecureMail Gateway, Messenger and Governikus Edition, only internal users are obliged to license, for whose entire outgoing and incoming e-mail the security policy (central policy + subject command) always yields "forward".

Passive Clients: An internal user counts as an obliged to license "**Passive Client**" if the central policy of Z1 is configured for him in a way only that incoming e-mail messages will be decrypted using the private mandator/domain key and/or that signatures of incoming e-mail message will be verified.

Attention: Passive Clients are solely intended for the **manual** e-mail correspondence. For automated e-mail traffic, Zertificon offers "High Volume/Automation Activation" licenses.

Active Clients: For the Z1 policy pattern that goes beyond that of the "Passive Clients" applies: An "**Active Client**" is an internal e-mail address for whose the central policy of Z1 for incoming and/or outgoing e-mail is configured in a way that Z1 provides one of the following operations: block, signature, signature verification, time stamp, time stamp verification, encryption, decryption with any sort of key.

Attention: Active Clients are solely intended for the **manual** e-mail correspondence. For automated e-mail traffic, Zertificon offers "High Volume/Automation Activation" licenses.

Z1 Automation/High Volume Activation: A "Z1 Automation/High Volume Activation" license is necessary if "Z1 SecureMail" systems process automatically generated outgoing e-mail traffic (outbound) or process incoming e-mail traffic that is automatically processed afterwards (inbound). Typically, among this comes e-mail traffic from and to e-business systems such as online shops, online auction houses, portals, bookkeeping systems, CRM, supply chain solutions, newsletters, list exploders, ERP- and EDI systems (SAP, ...) and so on. For each "Z1 SecureMail" system per mandator, one "High Volume/Automation Activation" license is to be acquired if by this system are performed "Active Client" or "Passive Client" services (see page 2) for automatically generated outgoing e-mail traffic (outbound) or for incoming e-mail traffic that is automatically processed afterwards (inbound). In doing so, the number of both internal and external e-mail addresses with automated e-mail traffic is irrelevant. A cluster system with N nodes is considered as one system. The "High Volume/Automation Activation" license is measured after the number of e-mail messages.

Perpetual License: A **Perpetual License** is a License that authorizes to a chronological unlimited use. Its acquisition corresponds to the purchase of a Z1 Software Solution. It does not include Z1 Software Maintenance and it does not include Z1 Software Support (must be acquired separately in each case).

Subscription License: A **Subscription License** is a License that authorizes to a time-limited use, such as for one year. Its acquisition corresponds to the renting of a Z1 Software Solution. It always includes Z1 Software Maintenance and Z1 Software Support.
